Is the procedure reimbursable in skilled nursing with mobile FEES providers?

The provider will need to verify with insurance and/or the facility where the FEES is being provided. The Medicare MAC that covers South Carolina currently has no restrictions on providing FEES. Developing Competency in FEES:

ASHA has developed a Dysphagia Competency Verification Tool (DCVT) that may be utilized within training programs, facilities, and continuing education courses to assist in determining competency for providing FEES procedures. There are no regulated minimum number of transnasal scope passes in the state of South Carolina or nationally. Some states may have regulatory or statutory guidance on FEES. SLPs should contact the state association or licensing board wherever they plan to complete a FEES procedure to ensure they are compliant with all legal guidelines.

To date there is no other national guidance from ASHA for facilities to develop a Policy and Procedure document.
